About

The White-Wilson Community Foundation, a 501(c)(3) nonprofit, was formed in 2012 to help improve health care in Okaloosa, Santa Rosa and Walton Counties. Goal

Giving

- Applications will be accepted January 17 – March 29, 2024.
- Grants are only awarded to not-for-profit health organizations and qualifying 501(c)(3) organizations.
- Recipients will be notified in April 2024, and funds will be awarded by May 2024. A partnership agreement will be provided upon notification.
- Organizations may request contributions annually or no more than once per 12-month period.

Exclusions

The White-Wilson Community Foundation does not award grants to the following:

- For-profit organizations
- Individuals
- Political or lobbying organizations
- Religious organizations for religious purposes

Consideration
